David Ciccoricco is an Associate Professor of English at the University of Otago in Dunedin, and Head of Programme for English and Linguistics.

Vicki Hearnshaw has contributed articles on the lives and works of New Zealand-based artists and photographers to peer-reviewed journals in this country and overseas for more than 30 years. This has included a challenging project on early women photographers of this country and their photograph collections.
