## Invitation to contributors

1. **Articles:** The editors welcome articles for publication in the *journal*. They also welcome statements of opinion and more speculative pieces for the *Commentary* section. An implied condition of submission is that the paper has not been submitted to any other publication. All papers are subjected to a refereeing process before an editorial decision is made.
2. **Submissions:** Articles must be submitted in triplicate. They must include an abstract of 100 words or less. Submissions should not normally exceed 6 000 words. All copies must be typed in *journal* style on one side only of the paper (preferably A4 or 210mm x 300mm) double spaced (*including footnotes and references*), with a margin. Footnotes, lists of references, lists of cases, tables etc. should be typed on separate sheets of paper and placed at the end of the manuscript. Authors should retain a copy of their manuscript.
3. **Comments on published articles:** Before communicating with the editor, the author of a comment on an article published in the *journal* must send a copy to the author of the original article, with a request for a response and explanation of any point on which the original author feels that he or she has been misunderstood. The commentator is asked not to submit anything to the editors until he/she has received a reply from the original author (or no reply is received). No comment should be longer than 1 500 words. When submitted (in triplicate), it should be accompanied by a statement that this preliminary procedure has been followed, and by 3 copies of any correspondence from the original author responding to the comment. It will then be refereed, and, if accepted for publication, the original author will be given an opportunity to reply.
4. **Copyright** of published articles is held by the New Zealand Institute of Industrial Relations Research Inc. No limitation will be placed on the personal freedom of the author to copy, or to use in subsequent work material contained in the paper.
5. **Payments** are not made to authors. Authors receive a free copy of the issue of the *journal* in which their article appears. Reprints may be ordered at prices advised with proofs.

## Preparation of manuscripts

1. **Style:** Articles must be submitted in the *journal's* style. For guides on style, authors should consult a recent issue. Particular attention should be paid to the method of citation and the style for lists of references (including the citation of legal cases and references). Authors may also find the *Style book* (3rd Ed.) prepared by the New Zealand Government Printer useful.
2. **Sub-headings:** Sub-headings should be typed lower case, major sub-headings in Roman, minor sub-headings in italics (or underlined).
3. **Footnotes:** Footnotes should be avoided whenever possible. Essential footnotes should be indicated by superscript figures in the text and collected on a single page placed at the end of the manuscript. The first footnote should be asterisked and contain: the author's position(s), affiliation(s) and any acknowledgements.
4. **Quotations:** Quotations longer than 35 words should be indented and single spaced. Short quotations should be enclosed in double quote marks (" ") and run on in the text.
5. **Underlining:** Only material to be italicized should be underlined.
6. **Tables and diagrams:** Tables and diagrams should be attached on separate sheets at the end of the manuscript. They should be numbered consecutively in arabic numerals and their place in the text indicated clearly. (a) *Tables* - Tables should follow the style of tables in recent issues of the *journal*. *N.B.* Tables must contain horizontal ruling only. (b) *Charts and diagrams.* Authors are responsible for preparing the final copy of any charts and diagrams. These should be drawn to a professional standard with black ink on white paper. The headings, labels, etc. should also be drawn professionally or written with Letraset or a similar method and reduced to a size suitable for inclusion directly into the final text. The original plus one reduced copy must be provided and it is the responsibility of authors to ensure that the charts and diagrams are proof read *prior* to submission.
7. **References:** References should be listed in full, alphabetically at the end of the paper in the following style:

No commentator will be allowed to make substantial alterations to a comment in proof (i.e. after the original author has written a reply).
