## **Treasurer's Report 2013**

#### Financial performance - profit and loss

The Association made an operating profit of \$1,287 during 2012/13.

The 2013 NZAS Conference was smaller than the 2012 Conference and this is was reflected in reductions in both income and expenditure. The surplus for the 2013 Conference was \$260.

Membership income for 2012/13 was up by \$2,583 on 2011/12. This increase reflects the addition of about 40 new members over the course of the year but it was offset by an increase in Bad debts and resignations (Profit and Loss) and by an increase in Accounts receivable (Balance sheet). Typically about 20% of members are in arrears at the end of each financial year. All the treasurer can do is send reminders. While some inertia is natural, it may also mean the Council, upon which the burden falls, is failing to make the case for continuing membership sufficiently compelling to drive subscription renewals.

Monetary changes related to memberships are reflected in membership numbers. These were essentially static over the 2012/13 year (Table 1). This results hides the flows involved: the gain of about 40 new members over the course of the year was offset by a similar number of losses through resignations and removals for bad debts arising from:

- members who resigned on receipt of 2012/13 invoices (because we invoice in advance, i.e. before any services are provided, this is not strictly a bad debt);
- people who resigned with arrears owing for 2011/12 without paying up;
- members gone with no address (with or without arrears);
- members who had ignored requests to pay subscriptions for two years.

New members were recruited as a result of the 2013 conference and continued to trickle in over the course of the year. As noted last year, some of these memberships are likely to be 'soft – i.e. they arise from people who join at the conference or via the

website but who do not pay the following year (usually becoming part of the first group in the bulleted list above).

The decrease in income from sales of *New Zealand Science Review* to libraries is an artefact. The 2011/12 income included a one-off payment of \$1,500 for open access to the Popper lectures in volume 69, number 1.

#### Financial position - balance sheet

The accumulated funds of the Association have increased by \$1,287 as a result of the operating surplus.

The Association is in a healthy financial position. We can well afford to run the 2014 Conference as planned in Auckland. We are also in a position to make contributions to worthy causes as we did in 2012/1.

The Council has agreed that the Association will commit \$5,000 to a repeat of the 'Survey of New Zealand Scientists and Technologists' provided that arrangements for this survey can be put in place.

#### Recommendations

I move that the Annual General Meeting of the NZ Association of Scientists:

*Approve* the 2012/13 accounts of the New Zealand Association of Scientists (Inc.).
